It is three times as large as the previous office. Over the past five years, the average annual growth rate of Synopsys' revenue in China was approximately 70 percent. Apart from its successful establishment in China, Synopsys formed a number of strategic partnerships in the China market, including founding the joint laboratory for advanced SoC design with the Chinese Academy of Sciences and supporting the construction of China state IC design incubators.
